And when I say "SNAP," I do mean food stamps; SNAP isn't limited to "food." Also, I'm speaking only of the regular food stamp program, not the "SNAP

Children's Program." This is the story of a challenge I received in my food stamp challenge from July 24 through September 2, 2016. On July 24, I sent a letter to the USDA for which I received a response on September 8, 2016. It was a letter admitting that the SNAP database had incorrectly reflected that I had received \$308 in SNAP benefits during July 2014. In fact, I had not. These represent the three stamps in my jar that are currently being renewed as I wrote this. I didn't notice the stamps were in

error because at the time the incorrect information was entered, I had just purchased 40 gallons of gas, \$56 in paper goods, and \$3 in groceries. Of course, I'm on a budget, so I can't afford to buy those things over and over. Also, I've been sending people to the grocery store once a week to pay for those things, so I don't remember having received them. Because of the SNAP card being in error, I'm paying for SNAP benefits that I didn't receive, which means that money doesn't go to the needy. It
