By JACK FREELAND Published: April 13, 2011 In a settlement announced on Monday, high school football players in Maine who were forced to play without pads and helmets because their school did not have a trainer were awarded more than \$3.1 million. The plaintiffs were among 31 boys and men from Orono and Rehoboth who had sued the school district in federal court after their playing days were ended in late December 2005, when coach Paul McMurtry and officials at Rehoboth High School barred the teams from using the school's lacrosse rink and ice rink after their insurance carrier informed the district that it would not pay for their medical care if they injured themselves. The coaches had been working without protection or oversight, according to the federal lawsuit filed in 2006 and made public last week by the plaintiffs. The coaches, who were not named in the suit, apparently had no training for a player who might sustain serious injury. The district was covered by insurance for noncontact injuries, but the district's liability carrier told them that the athletes would be required to play through certain injuries as part of the routine coverage. Because of that directive, the lawsuit alleged, the students were forced to continue playing under unsafe conditions on a daily basis. The settlement, which will be split evenly among the boys and men, adds nearly \$3.1 million to what the highest-earning plaintiff, the lead plaintiff, will get, said the lawyer for the plaintiff, Thomas McNamee, an Owls Head lawyer. "I think we did a good job," Mr. McNamee said of his client. "It's a victory in principal and in a way it is a victory that his boys aren't going to have to continue suffering from the inaction of the school district." The school district initially refused to pay for medical care for the former athletes, based on a policy change instituted last year by that insurer. After a June 2008 mediation, the court awarded the plaintiffs more than \$3 million each. The award will be split equally. The players will also be awarded 20 percent interest and 10 percent attorney's fees. No one else from the school was named as a defendant in the case, but both the school board and a school official individually were named in the suit. The settlement was never formally approved by the court, but at a hearing last week, the judge, Lance Walker, said it had reached an agreement in
